SUBJECT: Certified Statement of Vote

REQUEST(S):

That the Board of Supervisors:

Approve the Certified Statement of Vote, as submitted by the Registrar of Voters, for the 2024 Presidential General Election.

SUMMARY:

On November 5, 2024, the Registrar of Voters conducted the Presidential General Election. After the Official Canvass of an election is complete and per Elections Code 15372, the Registrar of Voters is required to prepare a certified statement of the results of the election and submit it to the governing body. The Governing Body shall declare the elected person(s) to each office voted on under its jurisdiction specifying the person(s) having the highest number of votes for the office as provided by law. The Registrar of Voters is also required to post the certified statement of results on their internet website. The Registrar of Voters certified the Statement of Vote on December 3, 2024.

The Certified Statement of Vote shall include the following:

1. Total number of ballots cast.
2. The number of votes cast at each precinct for and against each measure.

The Registrar of Voters processed a total of 139,860 ballots for the election. There were 218,999 registered voters in Tulare County at that time resulting in a 63.86% turnout. The ballots counted included vote by mail, all-mail precinct, processed ballots voted at the polls, provisional and conditional voter registrations.
