SUBJECT: Approve an agreement with The Source LGBT+ Center, Inc.

REQUEST(S):

That the Board of Supervisors:

1. Approve an agreement with The Source LGBT+ Center, Inc. to provide core sexually transmitted disease surveillance and disease intervention services, in an amount not to exceed \$174,656, retroactive from July 1, 2024, through June 30, 2026. This agreement is retroactive due to the time required to review and update the Scope of Work to align with grant guidelines, making it impracticable for the Board to take action prior to July 1, 2024.
2. Find that the Board had the authority to approve the agreement as of July 1, 2024, and that it was in the County's best interest to approve the agreement on that date.
3. Authorize the Chair of the Board to sign the agreement.

SUMMARY:

In January 2024, the California Department of Public Health (CDPH) awarded funding for two (2) years to the Tulare County Health and Human Services Agency's (HHSA) Public Health Branch. The purpose of this funding is for the implementation of public health activities related to monitoring, prevention, testing, and linkage to and retention in care activities for the most vulnerable and underserved individuals living with or at high risk for Sexually Transmitted Infections (STIs) in collaboration with community-based organizations (CBOs) providing services within Tulare County. This funding combines the previous Sexually Transmitted Disease (STD) Core and STD Prevention and Collaboration allocations authorized by California Health and Safety Code Section 120511, in which no less than 50% of the Collaboration funds shall be provided to one or more CBOs.

SUBJECT: Approve an agreement with The Source LGBT+ Center, Inc.

DATE: July 30, 2024

HHSA collaborates with The Source LGBT+ Center, Inc., a community partner for this program, to provide STD Prevention and Collaboration services and activities, but is not limited to voluntary screening for STDs among justice-involved youth and adults; technology, telehealth, and digital platforms and applications to enhance immediate access to screening, testing, and treatment; state-of-the-art testing modalities that ensure swift and accurate screening for and diagnosis of, STDs, and community-based testing and disease investigation.

This agreement did not go through the Request for Proposal (RFP) process because it is for the continuation of services.

FISCAL IMPACT/FINANCING:

Funding in an amount not to exceed \$174,656 is for the period of July 1, 2024, through June 30, 2026. This agreement is funded through the California Department of Public Health, STD Prevention and Collaboration grant allocation. The program's expenses and revenues will be budgeted in HHSA's budget unit 001-142-6064-7043. An amount of \$87,328 will be allocated for Fiscal Years 2024/2025 and 2025/2026. There is no net County cost to the general fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

This agreement increases our ability to meet the County's five-year strategic plan, specifically the Quality-of-Life Initiative that encourages innovative provision of the quality supportive services for at-risk adults, youth, and children in state and federally- mandated programs. This agreement will assist those in our community who have no other source of care and are in the at-risk category by linking them to services and providing non-medical case management.
