**SUBJECT:** Terminate Agreement No. 30370 with the California Department of Health Care Services

**REQUEST(S):**

That the Board of Supervisors:

Terminate Agreement No. 30370 with the California Department of Health Care Services for the delivery of Drug Medi-Cal Organized Delivery System services to County clients, effective December 31, 2024.

**SUMMARY:**

The Tulare County Health and Human Services Agency's (HHSA) Behavioral Health Branch and the California Department of Health Care Services (DHCS) entered into Agreement No. 30370 on September 28, 2021, for the delivery of Drug Medi-Cal Organized Delivery System (DMC-ODS) services to County clients. Agreement No. 30370-A was approved on January 10, 2023, Agreement 30370-B was approved October 24, 2023, and Agreement No. 30370-C was approved June 4, 2024. Pursuant to Exhibit E, Paragraph 2 of the agreement, the DHCS is authorized to cancel the agreement. On October 25, 2024, the DHCS provided written notice that the agreement will be canceled effective December 31, 2024. The DHCS is canceling the agreement because, on January 1, 2025, the DHCS and the HHSA will enter into a new Integrated Agreement No. 24-40147 to deliver both SMHS and substance use disorder services under the DMC-ODS. Integrated Agreement No. 24-40147 will wholly replace the current agreement.

**FISCAL IMPACT/FINANCING:**

The revenue provided to the County by Agreement No. 30370, No. 30370-A, 30370-B, and 30370-C, will not be disrupted. The seamless transition to the DHCS Integrated Agreement No. 24-40147 will not disrupt the disbursement of funds.

**LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:**

The County's five-year strategic plan includes the Quality of Life Initiative, which encourages the innovative provision of quality supportive services for at-risk adults, youth, and children in state and federally mandated programs. The seamless transition of the HHSA and DHCS to an integrated SMHS and DMC-ODS will continue to uphold the delivery of services regardless of the termination of Agreement No. 30370, No. 30370-A, 30370-B, and 30370-C.
