SUBJECT: Approve an Agreement with the Cutler-Orosi Joint Unified School District

REQUEST(S):

That the Board of Supervisors:

1. Approve an agreement with the Cutler-Orosi Joint Unified School District for the Sheriff's Office to provide School Resource Officer services on the district campuses, in an amount not to exceed \$280,925, retroactive July 1, 2024 through June 30, 2025. The Agreement is retroactive due to a delay in receiving the agreement for processing making it impracticable for the Board to take action prior to the effective date; and
2. Find that the Board had the authority to enter into the Agreement as of July 1, 2024, and that it was in the County's best interest to enter into the Agreement on that date; and
3. Authorize the Chair to sign the Agreement.

SUMMARY:

The Cutler-Orosi Joint Unified School District is seeking to continue to partner with the Sheriff's Office to provide two (2) Sheriff deputies to serve as School Resource Officers on the district campuses.

Under the agreement, the deputies provide a visible law enforcement presence on campuses; assists school officials in enforcing school laws; utilizes intervention and prevention skills with students who are involved in criminal activity; acts as a resource deputy for school personnel; and provides classroom instruction on law enforcement issues such as gang awareness.

DATE: July 9, 2024

FISCAL IMPACT/FINANCING:

The Sheriff's Office will be compensated up to \$280,925 by the Cutler-Orosi Joint Unified School District for the salary, benefits, and operating costs for the School Resource Officers. Compensation revenue to the Sheriff's Office will be included in the Sheriff's Fiscal Year 2024/25 recommended budget. There is no additional net County cost to the General Fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's strategic plan includes the Safety and Security initiative. This agreement supports this initiative by collaborating with the school district to provide a visible deterrent at schools while having an immediate response if necessary.
