**SUBJECT:** Approve an agreement with the Monson-Sultana Joint Union Elementary School District

**REQUEST(S):**

That the Board of Supervisors:

1. Approve an agreement with the Monson-Sultana Joint Union Elementary School District for the Sheriff's Office to provide School Resource Officer services on the district campus, in an amount not to exceed \$42,927, effective August 7, 2024, through May 23, 2025; and
2. Authorize the Chair to sign the Agreement.

**SUMMARY:**

Monson-Sultana Joint Union Elementary School District is seeking to continue to partner with the Tulare County Sheriff's Office (TCSO) to provide a Sheriff's deputy to serve as a School Resource Officer on the District campus.

Under the agreement, the deputy provides a visible law enforcement presence on campus; assists school officials in enforcing school rules/laws; utilizes intervention and prevention skills with students that are involved in criminal activity; acts as a resource deputy for school personnel; and provides classroom instruction on law enforcement issues such as gang awareness.

**FISCAL IMPACT/FINANCING:**

The TCSO will be compensated up to \$42,927 by the Monson-Sultana Joint Union Elementary School District for the salary, benefits, and operating costs for the School Resource Officer. Compensation revenue to the Sheriff's Office will be included in the Sheriff's Fiscal Year 2024/25 recommended budget. There is no additional net County cost to the General Fund.
