**SUBJECT:** Approve an agreement with the Tulare Joint Union High School District

**REQUEST(S):**

That the Board of Supervisors:

1. Approve an agreement with the Tulare Joint Union High School District for the Sheriff's Office to provide School Resource Officer services on the district campus, in an amount not to exceed \$121,050 effective August 8, 2024 through June 5, 2025; and
2. Authorize the Chair to sign the Agreement.

**SUMMARY:**

The Tulare Joint Union High School District is seeking to continue to partner with the Sheriff's Office to provide a Sheriff's deputy to serve as a school resource officer on the district campus.

Under the agreement, the deputy provides a visible law enforcement presence on campus; assists school officials in enforcing school laws; utilizes intervention and prevention skills with students who are involved in criminal activity; acts as a resource deputy for school personnel; and provides classroom instruction on law enforcement issues such as gang awareness.

**FISCAL IMPACT/FINANCING:**

The Sheriff's Office will be compensated up to \$121,050 by the Tulare Joint Union High School District for the salary, benefits, and operating costs for the school resource officer. Compensation revenue to the Sheriff's Office will be included in the Sheriff's Fiscal Year 2024/25 recommended budget. There is no additional net County cost to the General Fund.
