NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the Tulare County Board of Supervisors will hold a public hearing on Tuesday, April 1, 2025, at 9:00 a.m., or as soon thereafter as it can be heard, in the Chambers of the Board of Supervisors, Administration Building, County Civic Center, 2800 West Burrel, Visalia, California.

This public hearing pertains to the adoption of a resolution pursuant to Section 50402 of the Government Code. Section 50402 permits Tulare County to charge fees for the use of and services provided at County Parks.

The increase of park fees is imperative to sustain the upkeep of all amenities, compounded by the inflation-induced rise in the costs of goods and services, necessitating adjustments to maintain quality standards at all County Parks.

All interested persons may appear and be heard at said time and place. If you challenge the decision of the Board of Supervisors on the foregoing matter in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Board of Supervisors of the County of Tulare at, or prior to, the public hearing. Judicial review of this Board of Supervisors decision is appealable pursuant to Code of Civil Procedure Section 1094.6.
