AN ORDINANCE AMENDING ARTICLE 3 OF CHAPTER 1 OF PART III OF THE  
ORDINANCE CODE OF TULARE COUNTY PERTAINING TO SPEED LIMITS.

THE BOARD OF SUPERVISORS OF THE COUNTY OF TULARE ORDAINS AS  
FOLLOWS:

**Section 1.** Article 3 (“Speed Limits”) of Chapter 1 (“Speed Limits”) of Part III (“Streets  
and Highways”) of the Ordinance Code of Tulare County is amended to read as follows:

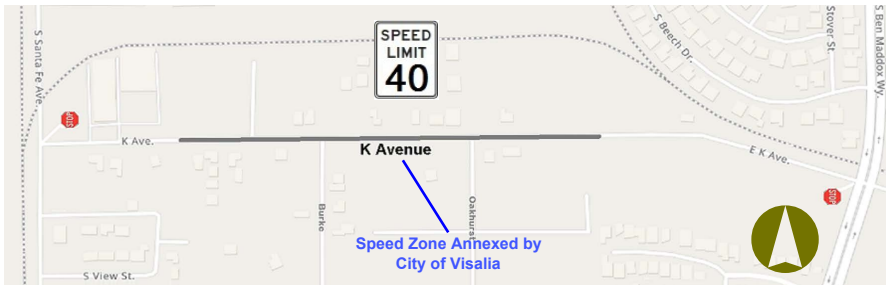

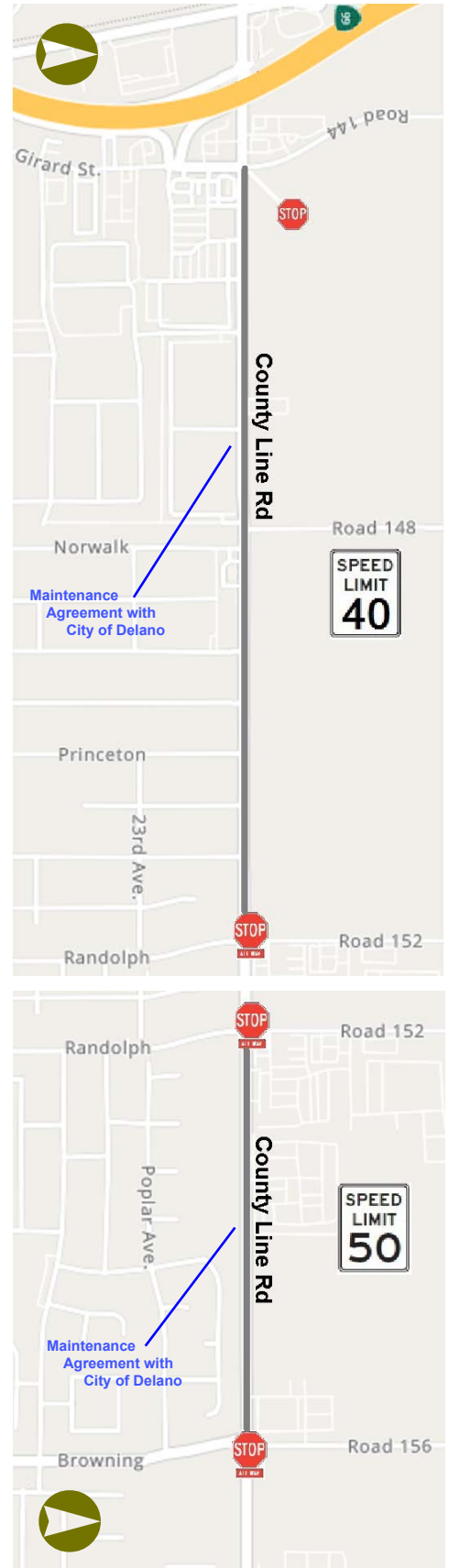

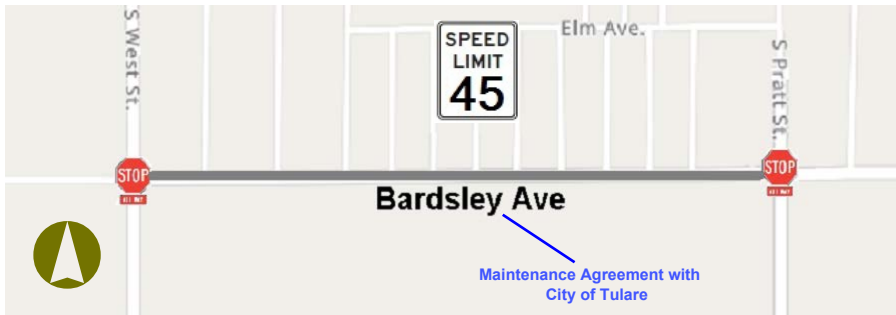
## Visalia: K Avenue



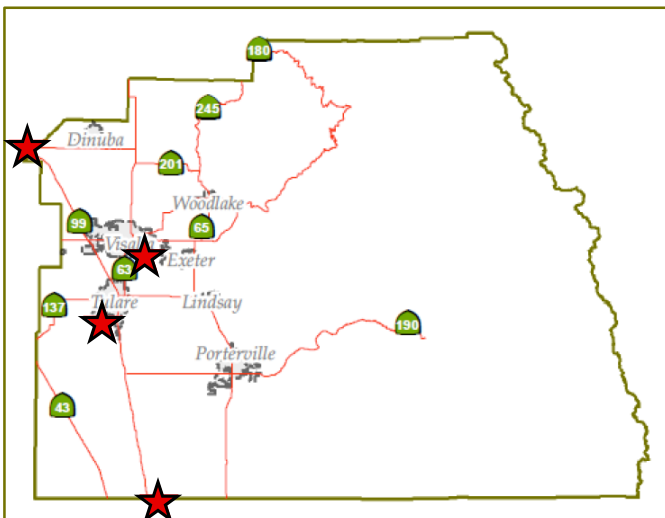
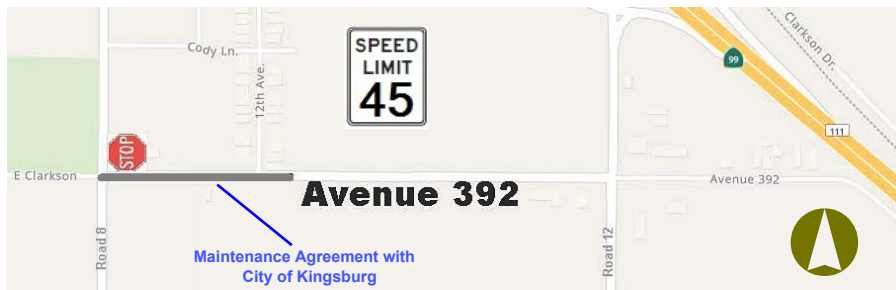
## Delano: County Line Road

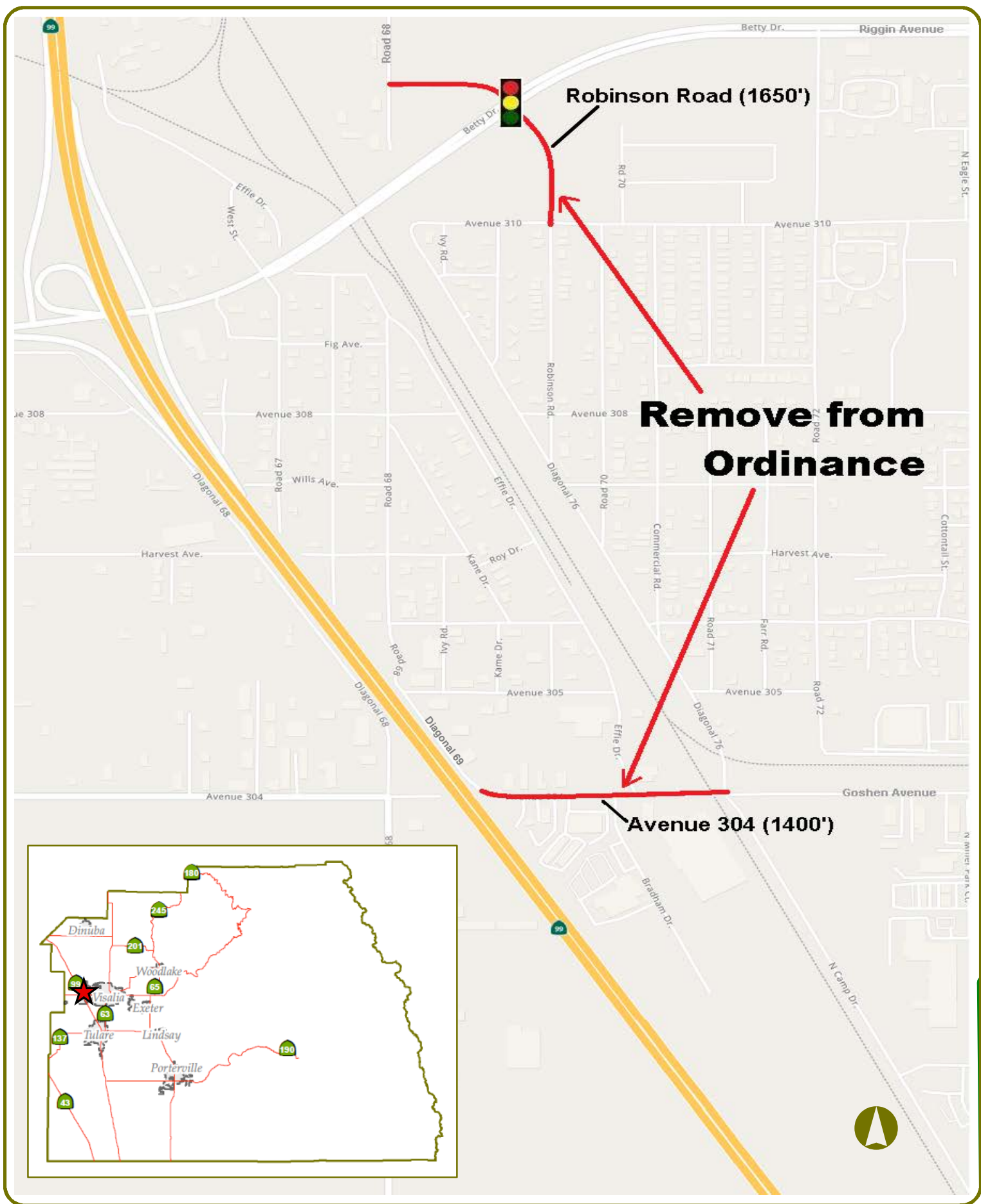

Maintenance Agreement Removals

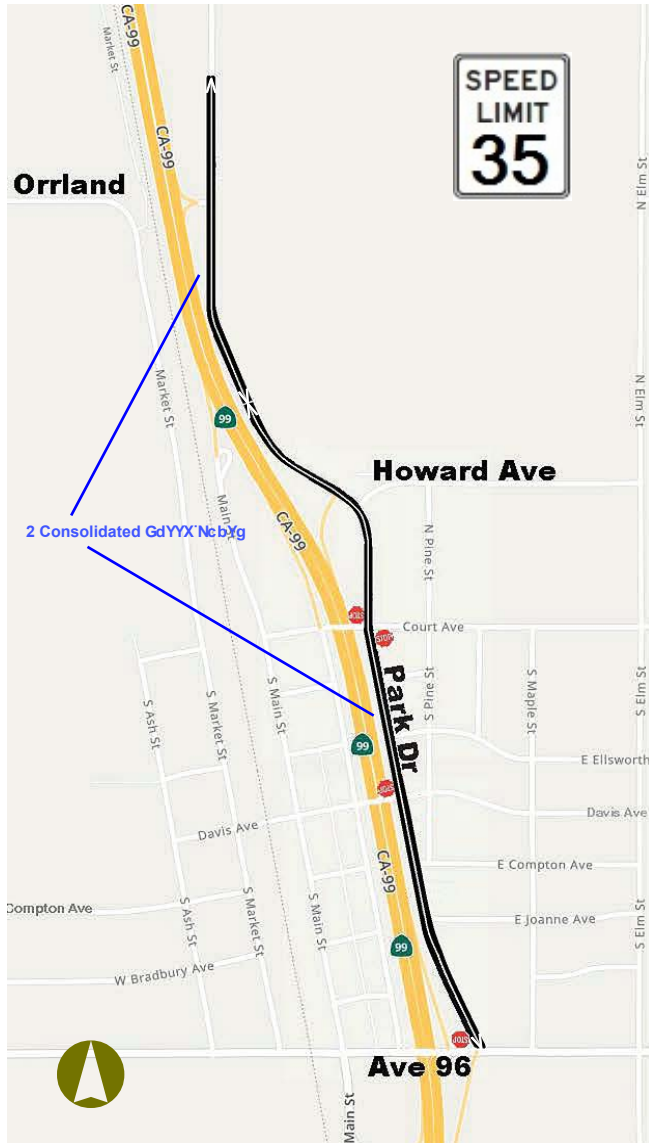

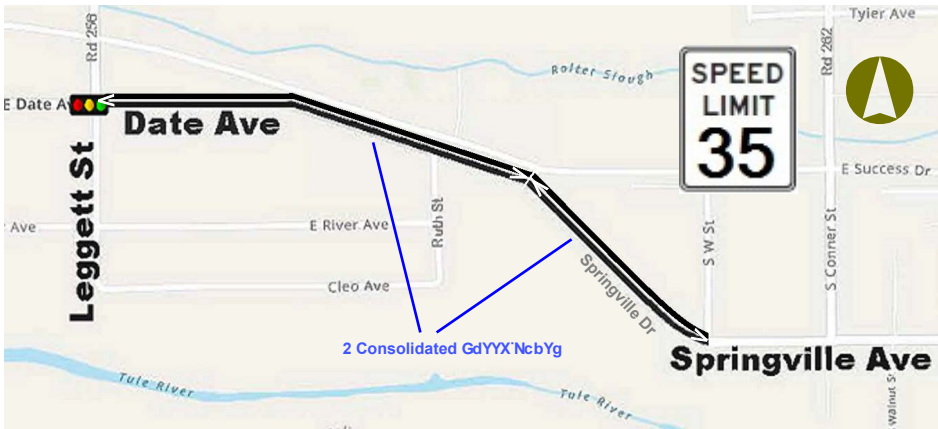

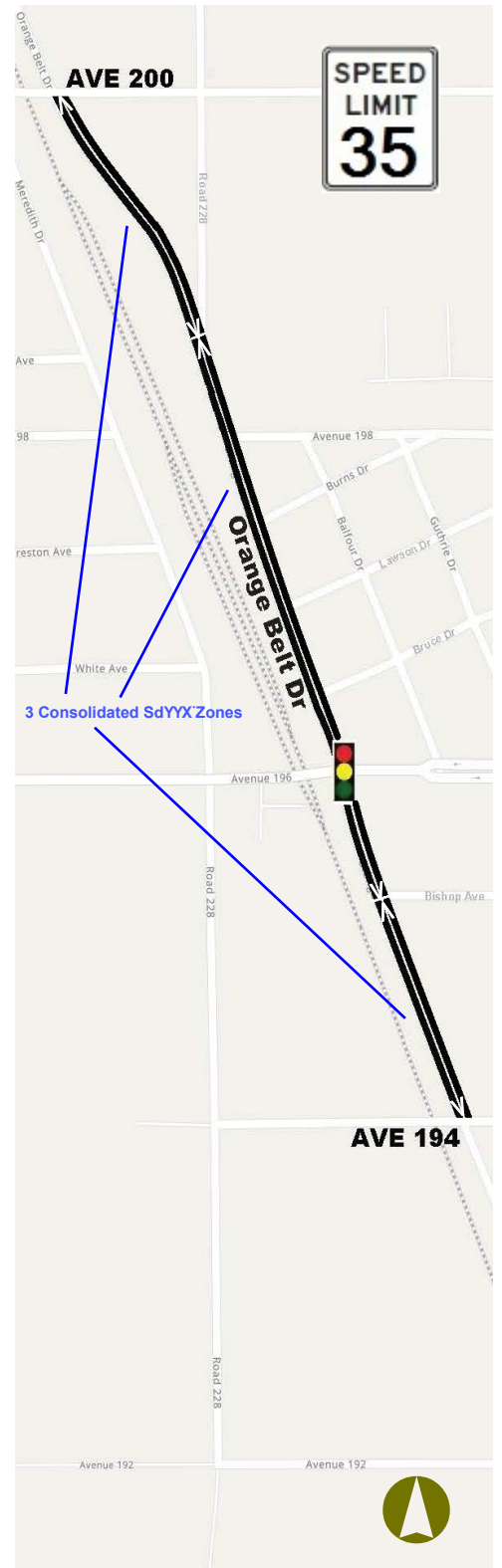
**Vicinity Map I - Consolidated Speed Zones

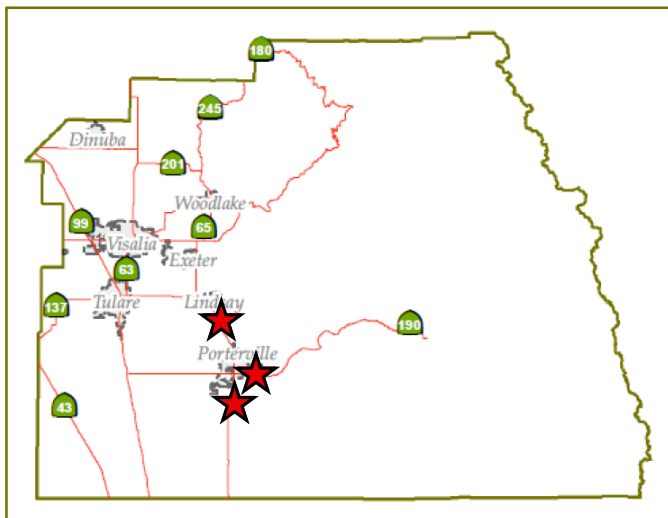
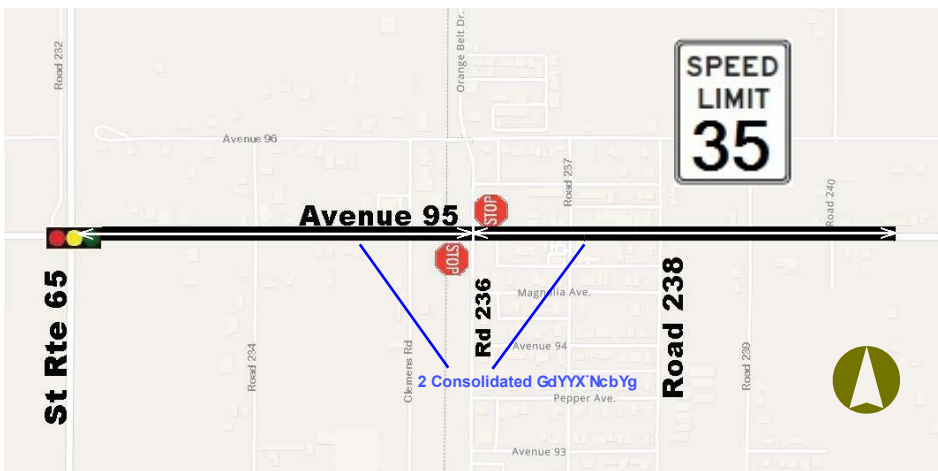
## Date Avenue in Porterville

in Porterville, Strathmore & Terra Bella

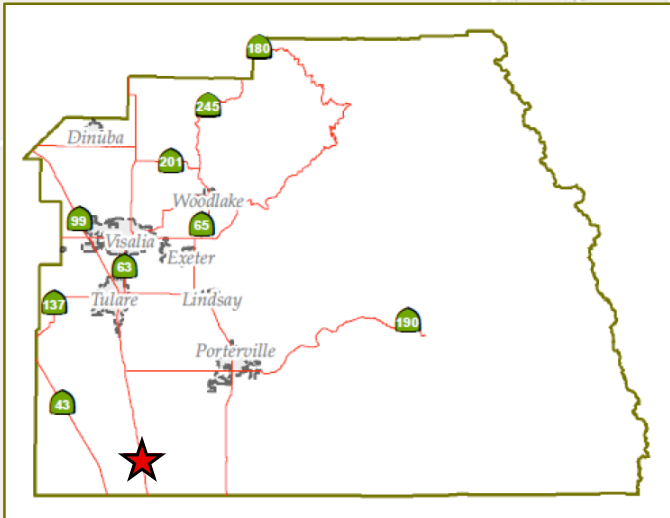

## PROPOSED ORDINANCE

PURSUANT TO GOVERNMENT CODE SECTION 25124, THE FOLLOWING IS A SUMMARY OF A PROPOSED ORDINANCE AMENDING ARTICLE 3 OF CHAPTER 1 OF PART III OF THE ORDINANCE CODE OF TULARE COUNTY, PERTAINING TO SPEED LIMITS.

### SUMMARY OF PROPOSED ORDINANCE

The proposed ordinance would extend existing speed zones, add new speed zones, remove an existing speed zone, and combine and simplify speed zones for various locations throughout the unincorporated areas of Tulare County. It also removes from the ordinance code speed zones that are now under the jurisdiction of cities either due to annexations or maintenance agreements. This ordinance will also adjust some and update all existing speed zones per Vehicle Code sections 627 & 40802 and will supersede all other revisions.

The following speed zones will be removed from the ordinance code because they were incorporated into a city, included in a new maintenance agreement, or do not meet the minimum length of one-half mile: "K" Road from the Visalia City Limits east of Santa Fe Road to the Visalia City Limits east of Burke Street (Visalia Area); County Line Avenue from Diagonal 144 to Road 152 (Delano Area); County Line Avenue from Road 152 to Road 156 (Delano Area); Bardsley Avenue from West Street to Pratt Street (Tulare Area); Avenue 392 from Road 8 to 970 ft east of Road 8 (Kingsburg Area); Avenue 304 from Diagonal 69 to the Visalia City Limits (Visalia Area); and Robinson Road from Avenue 310 to Road 68 (Goshen Area).

The following speed zones will be consolidated from multiple previous speed zones into a new single speed zone: Front Road from a point 800 ft south of Chaparral St to a point 800 ft north of Sierra Avenue - 35 MPH (Earlimart); Park Drive from Terra Bella Avenue to a point 800 ft north of Orrland Avenue - 35 MPH (Pixley); Date Avenue/Springville Drive from Leggett Street to Springville Avenue - 35 MPH (Porterville Area); Orange Belt Drive from Avenue 194 to Avenue 200 - 35 MPH (Strathmore); Avenue 95 from State Route 65 to a point 1500 ft east of Road 238 - 35 MPH (Terra Bella).

The following speed zones will be adjusted for length only: Road 192 from a point 500 ft north of Avenue 148 to a point 1,500 ft north of Avenue 152 - 45 MPH (Cotton Center); El Monte Way from Road 120 to Road 124 - 40 MPH (Cutler-Orosi); Diagonal/Road 68 from Avenue 304 to Avenue 308 - 45 MPH (Goshen); Road 196 from a point 500 ft south of Avenue 194 to Avenue 196 - 35 MPH (Plainview); Road 156 from a point 900 ft south of Avenue 295 to Avenue 296 - 35 MPH (Visalia Area); Road 216 from a point 200 ft south of Avenue 252 to a point 300 ft north of Avenue 254 - 45 MPH (Tonyville).

The following speed zones will be adjusted for length have their speed reduced by 5 MPH: El Monte Way from a point 630 ft east of Road 130 to Road 136 - 45 MPH (El Monte Way); Washington Avenue from Church Road to Dietz Road - 35 MPH (Earlimart);

and Road 192 from Avenue 144 (State Route 190) to a point 500 ft north of Avenue 148 - 35 MPH (Poplar).

The following speed zones will be reduced by 5 MPH: Armstrong Avenue from Front Road to Lane Road - 35 MPH (Earlimart); Sierra Avenue from Front Road to North Thompson Road - 35 MPH (Earlimart); Washington Avenue from Howard Road to Valente Road - 35 MPH (Earlimart); Avenue 308 from Camp Drive to Road 76 - 35 MPH (Goshen); Avenue 328 from Road 156 to Road 160 - 35 MPH (Ivanhoe); Road 156 from Avenue 328 to a point 500 ft north of Avenue 332 - 35 MPH (Ivanhoe); Terra Bella Avenue from Airport Street to Ash Street - 45 MPH (Pixley); Terra Bella Avenue from Ash Street to a point 1,100 ft east of Elm Street - 35 MPH (Pixley); Olive Avenue from a point 600 ft west of the west edge of the Tule River Bridge to the Porterville City Limits at Elderwood Street - 45 MPH (Porterville Area); Roby Avenue from Ruth Street to Olive Drive/Doyle Street - 40 MPH (Porterville Area); Success Drive from Leggett Street to Springville Avenue - 35 MPH (Porterville Area); Richgrove Drive from a point 500 ft south of Ames Drive to Avenue 8 - 35 MPH (Richgrove); Road 156 from Inyo Avenue to Avenue 384 (State Route 201) - 45 MPH (Seville); Avenue 416 from Road 100 to Road 108 - 40 MPH (Sultana); Diagonal 39 from State Route 99 to Merritt Drive - 35 MPH (Traver); Avenue 296 from Road 152 to a point 600 ft east of Road 158 - 40 MPH (Visalia Area); Avenue 168 from a point 400 ft west of Road 164 to a point 1,000 ft east of Road 168 - 40 MPH (Woodville); Road 168 from a point 2,500 ft south of Avenue 167 to Avenue 168 - 40 MPH (Woodville).

The following speed zones will be reduced by 5 MPH, with an additional 5 MPH reduction due to safety concerns: Betty Drive from Road 63 to Robinson Road - 35 MPH (Goshen); Avenue 408 from Road 124 to Road 128 (State Route 63) - 35 MPH (Cutler-Orosi); and Avenue 196 from State Route 65 to Road 232 - 35 MPH (Strathmore).

The following are new speed zones that will be added to the Ordinance Code: Church Road from Armstrong Avenue to Sierra Avenue - 35 MPH (Earlimart); Road 234 from a point 1,630 ft south of Avenue 92 to Avenue 95 - 35 MPH (Terra Bella); and Avenue 280 from Drives 85/88 to the Visalia City Limits - 55 MPH (Visalia Area).

The ordinance will also make minor adjustments to some descriptive language for better consistency. Adjustments will be made to the order of the speed zones listed in the ordinance code in accordance with other changes.

The effective date of these changes would be thirty (30) days after adoption by the Board of Supervisors.

The ordinance herein summarized will be considered by the Board of Supervisors of the County of Tulare, State of California, on January 28, 2025, at a regular public meeting of said Board. At least five (5) days prior to that date a certified copy of the full text of the proposed ordinance shall be posted in the office of the Clerk of the Board of Supervisors and shall be available for public inspection at that location.
