ORDINANCE NO. 3632 AN ORDINANCE AMENDING ORDINANCE NO. 352, THE ZONING ORDINANCE OF TULARE COUNTY, BEING AN ORDINANCE ESTABLISHING AND REGULATING LAND USES WITHIN CERTAIN ZONES IN THE COUNTY OF TULARE. THE BOARD OF SUPERVISORS OF THE COUNTY OF TULARE DO ORDAIN AS FOLLOWS: Section 1. Paragraph B of Section 3 of Ordinance No. 352 of the County of Tulare is hereby amended by the adoption of an amended map of a portion of Section 17, Township 28 South, Range 25 East, Mount Diablo Base and Meridian, being a subdivision of Part 336 of the Official Zoning Maps. A map showing Zone Change No. PZC 22-012 approved for approximately 67.59 acres is attached hereto and incorporated herein by reference. The new zoning will be	R-A-43 (Rural Residential - 43,000 sq. ft. minimum). Section 2. The property affected by the zoning reclassification from AE-20 (Exclusive Agriculture - 20 Acre Minimum) and R-A-100 (Rural Residential - 100,000 sq. ft. minimum), filed as is briefly described as follows: Being a 67.59-acre site, located on Tulare County Assessor Parcel Numbers (APNs) 079-071-014, 079-072-005, and 079-073-001. The subject property is located on the west side of Road 132, North of St Johns River, Visalia, CA. Section 3. This Ordinance shall take effect thirty (30) days from the date of the passage hereof, or if published more than 15 days after the date of passage, then 30 days after publication, whichever is later, and, shall be published once in the The Sun-Gazette, a newspaper printed and published in the County of Tulare, State of Cali-	fornia, together with the names of the members of the Board of Supervisors voting for and against the same.
