REQUEST(S):

That the Board of Supervisors:

1. Authorize the submittal of the Local Early Action Planning Report and attachments including the draft Municipal Service Reviews and County Development Standards to the California Department of Housing and Community Development for the Local Early Action Planning (LEAP) Grant.
2. Authorize the Tulare County Local Agency Formation Commission to adopt and incorporate the updated Municipal Service Reviews.
3. Authorize the updated Tulare County Improvement Standards to be brought before the Board of Supervisors for adoption and incorporation by reference into the General Plan Public Utilities Element upon completion; and
4. Designate the Resource Management Agency Director or designee to act as the Environmental Officer in all matters pertaining to this grant.

SUMMARY:

In May of 2022, the County of Tulare received \$565,000 from the California Department for Housing and Community Development (HCD) through the Local Early Action Planning (LEAP) Grant, of which \$500,000 were allocated to the County of Tulare and \$65,000 to the City of Lindsay. The County served as an entity for the City of Lindsay's funds due to HCD's Letter Finding to not allow the City to apply.

The County's main LEAP-funded project consisted of updating the Municipal Service

Reviews (MSRs) for special districts that provide urban services within Tulare County with the intent of identifying infrastructure and service capabilities and deficiencies throughout the County. An MSR is an in-depth analysis to determine the adequacy of municipal services being provided by a local agency under the Local Agency Formation Commission (LAFCO). The MSR is used by LAFCO, as well as other associated agencies and the public, to gain an understanding of the services provided and to identify opportunities for cooperation and greater efficiency among service providers. The term “municipal services” generally refers to the full range of governmental services that a public agency provides or is authorized to provide.

In February of 2023, the County entered into an agreement with Provost & Pritchard Engineering Group, Inc., for updating the MSRs. Tulare County LAFCO was also engaged in the review and approval of the MSRs. In March of 2024, the County entered into an agreement with 4Creeks Inc., a consulting firm, to update and improve the County’s Accessory Dwelling Unit (ADU) Ordinance Guidelines.

Due to the MSRs not being updated since the mid-2000s, there was limited updated information on the status of the County’s existing infrastructure. As a result of the MSR updates in the four groups of districts and service areas, infrastructure conditions can be provided to potential home builders as the County tries to assist developers in locating in communities that have adequate infrastructure. The updated MSRs also assist in preparation of and maintaining the County’s Housing Element, Groundwater Management Act, CV-Salts, and ability to provide water quantity and quality and improved roadway infrastructure to projects within the districts.

The City of Lindsay’s LEAP-Funded Project consisted of updating the City’s Zoning Ordinance, Subdivision Ordinance and Development Standards. The updates brought ordinances and standards into compliance with the City’s updated 2019 Housing Element and the current General Plan.

In September of 2022, the County entered into an agreement with 4Creeks, Inc., to update the City of Lindsay’s Zoning Ordinance, Subdivision Ordinance, and Development Standards.

In November 2024, the County amended its agreement with 4Creeks, Inc., to add scope to prepare updates to County standards. To date, two of the four planned submittals have been received. The remaining submittals will undergo review and revision, with the final submittal to be completed by June 2025.

Following this meeting, Public Works will conduct public outreach to solicit feedback from engineers, developers, utilities, contractors, and other stakeholders. The outreach period is expected to last approximately six weeks, allowing for industry input on the potential impacts of the proposed standards. If only moderate revisions are required, Public Works staff will complete the necessary adjustments within an estimated one-month period.

Upon completion of the revisions Public Works will bring the updated Improvement Standards to the Board of Supervisors for Adoption.

FISCAL IMPACT/FINANCING:

Carryover funds will be used to update the Tulare County Improvement Standards, originally adopted on January 16, 1973, and last revised on December 10, 1991. Funding to support this effort is provided by revenue from LEAP and from the County Road Fund.

LINKAGE TO THE COUNTY OF TULARE STRATEGIC BUSINESS PLAN:

The County's five-year strategic plan includes the Safety and Security Initiative with goals such as improving and maintaining adequate transportation infrastructure and providing for a safe and adequate water supply. Further, updated Improvement Standards will increase governmental efficiencies by meshing current development trends and practices with the County's policies for construction of public infrastructure.


1. Brief Summary


In May of 2022, the County of Tulare received fully executed Standard Agreement No. 21-LEAP-17083 in the amount of \$565,000 of which \$500,000 were allocated to the County of Tulare and \$65,000 to the City of Lindsay.

The County's main LEAP-funded project consisted of updating the Municipal Service Reviews (MSRs) for special districts that provide urban services within Tulare County with the intent of identifying infrastructure and service capabilities and deficiencies throughout the County. 



Enhanced Web Platform for Municipal Code and Upgrade Website: City website has been updated; the city municipal code has been converted to current "Muni Code" configuration.

Modernize and Improve Planning and Permitting System: Improvements have been incorporated into operations within City Services Department. Planning application and building permit process has been upgraded to include web access to all necessary applications and information. Internal application tracking (both planning and building) has been incorporated. Incorporated digital tracking of planning applications and building permits for all office and field staff (including portable laptop or notepads) as well as general public ability to track applications or permits. Integrated GIS-centric planning and permitting database.

Update Service Element of the General Plan: This grant allowed the County to add its ability to focus developers on projects and project areas, where they can work with the Service Districts and Cities/Communities to provide housing. Updating the MSRs also allowed the County to update its Public Services Element of the General Plan and update its development standards.

2. Lead Agency and Partnerships

The County of Tulare as lead agency administered the grant including the City of Lindsay's LEAP allocation. In February of 2023, the County entered into an agreement with Provost & Pritchard Engineering Group, Inc. for updating the Municipal Service Reviews. Tulare County LAFCO was also engaged in the review and approval of the MSRs. In March of 2024, the County entered into an agreement with 4Creeks Inc., a consulting firm, to update and improve the County's AUD Ordinance Guidelines. In September of 2022, the County also entered into an agreement with 4Creeks Inc. to update the City of Lindsay's Zoning Ordinance, Subdivision Ordinance, and Development Standards.

3. Drivers & 4. Engagement Process

Passed in 2017, California State Assembly Bill 1397 requires local governments to prove that their general plan include sufficient "adequate sites" to comply with their housing element, and that all such sites have a realistic potential for new housing development. When developing the MSRs, it assisted local communities to have a realistic development capacity, provided an analysis of non-vacant and underutilized sites, and identified environmental constraints and adequate infrastructure.

California State Senate Bill 35 (2017) is aimed at addressing the state's housing shortage and high housing costs. Specifically, it requires the availability of a Streamlined Ministerial Approval Process for developments in localities that have not yet made sufficient progress towards their allocation of the regional housing need. Eligible developments must include a specified level of affordability, be on an infill site, comply with existing residential and mixed-use general plan or zoning provisions, and comply with other requirements such as locational and demolition restrictions. The intent of the legislation is to facilitate and expedite the construction of housing. In addition, as part of the legislation, the Legislature found ensuring access to affordable housing is a matter of statewide concern and declared that the provisions of SB 35 would apply to all cities and counties. Updating the City of Lindsay's improvement (development) standards will streamline the application process by having all the standards in one location on the City's website.

Other drivers in this task included a collaboration of County staff (RMA and LAFCO) and consultants (Provost and Prichard, 4Creeks, and Skylab) to come together with non-



government organizations (NGOs), including: CSDs, CSA, IDs, PUDs, to update MSR. Much of the data collected, e.g., board members, announcements, maps, agendas & minutes, operations, hours of operation, audits, etc., could be found on most of the websites from aforementioned districts/service areas. If smaller districts did not contain data needed to update the MSR on their websites, interviews with staff were conducted.

The engagement included many stakeholders. In general, those that benefit from the MSR and City of Lindsay improvement standards include the residents that live in districts, service areas or the City of Lindsay. For the MSR, stakeholders included the districts identified in Section 1, Brief Summary, include 49 districts and service areas. Engagement was primarily through email communications and verbal communications.

5. Challenges

CSDs, CSAs, IDs and PUDs have small staffs and some are volunteer positions. Due to amount of information required to update MSR sections, it was sometimes difficult to gather information in a timely manner.

6. Outcomes

Because the MSR have not been updated since the mid-2000s, there was limited updated information on the status of the County's existing infrastructure. As a result of the MSR updates in the four groups of districts and service areas, infrastructure conditions can be provided to potential home builders as the County tries to assist developers in locating in communities that have adequate infrastructure. The updated MSR also assist in preparation of and maintaining the County's Housing Element, Service Element of the General Plan, Groundwater Management Act, CV-Salts, and ability to provide water quantity and quality and improved roadway infrastructure to projects within the districts.

LAFCO also amended its MSR Policy Element to allow for greater flexibility in the process and clean up some "awkward verbiage", according to LAFCO staff.

7. Replicability

Aspects of the project that could be replicated in other communities include utilization of the improvement (development) standards in other jurisdictions as background documentation to develop their own standards. In fact, the City of Lindsay Improvement Standards utilized City of Visalia updated development standards as background, and County of San Joaquin standards were used by Tulare County as background for its updated improvement standards. These standards will be made available to other jurisdictions as well to help in their updating processes.


